# **Program Information**

Unit Code: HCFP 301

Unit Name: Personal and Professional Development in Health & Social Care

The purpose of this module is to familiarize learners with personal growth and reflective practice, two critical components of positions in healthcare provision. Health and social care professionals have a professional obligation to preserve the value of their skills and understanding, which they do via further learning and reflection on their work. Additionally, the unit allows learners to investigate the use of such critical review to enhance their performance and guide their progress.

Unit Name: Effective Communications in Healthcare Settings

This module aims to equip students with the fundamental and critical skills necessary for effective communication in health and social care settings. Learners will understand the many modes of communication — non-verbal, spoken, written, and information technology. This unit will enable learners to communicate successfully across various situations and messages by picking the most efficient mode of communication for the circumstance and statement at hand.

**Unit Name:** Introduction to Health and Social Care

The module's primary purpose is for learners to know how it would be to engage in health and social care, such as the duties associated with preserving the health and safety of and protecting the rights of those in their care. They will recognize the importance of maintaining a constant awareness of data security, confidentiality, and the possibility of discriminatory activity. 
Unit Name: Equality, Diversity, and Inclusion in Health and Social Care Settings

This module introduces individuals to the information and skills necessary to operate equitably and inclusively in the Health and Social Care environment. The learner will learn how to obtain information, guidance, and assistance on diversity,

Unit Code: HCFP 305

Unit Name: Effective Handling of Healthcare Information

This module will examine concerns of confidentiality and ethical behavior associated with the storage and use of information. Additionally, the subject addresses the knowledge and abilities necessary to create and support sound information recording, sharing, storage, and access practices.



### **Important Definitions:**

- Total Module Time (TMT) is the number of hypothetical hours that reflects an estimation of the overall time that might reasonably be anticipated to be needed for a learner to accomplish and show the level of attainment required for the granting of a certificate.
- Guided Learning Hours (GLH) is described as the times during which an instructor, lecturer, or other staff member is accessible to give direct instruction or guidance to a learner pursuing a certification.
- The credit value of a Module or Unit is defined as the number of credits that may be granted to a student upon successful completion of the module's learning objectives and goals. One Beta College Credit is equivalent to ten TMT hours.

- Must be 16 years of age
- Academic documents copies (Certificate & Transcript) of High School or equivalent
- **English Language Proficiency is encouraged.**
- Mature Learners Entry Scheme
